The book is structured in four sections: concepts, structures, empowerment and spatial quality. The book concludes by putting forward an outlook for future action. (*English edition*)

Esta publicación supone un paso adelante en todas estas cuestiones, aportando novedades en el marco teórico, pero también ofreciendo herramientas de aplicación en la esfera profesional y formativa que puedan servir de guía en todo el contexto europeo para un urbanismo con mayor sensibilidad al género.
